

For PRAKSIS, 2014 also signifies the completion of ten (10) years of humanitarian action.

It was October of 2004 when we started, with many worries, with fear, with hesitation and plenty of insecurity! A bunch of people embarked on a mission to make the impossible possible.

A new Non-Governmental Organization among hundreds of others that would make a difference! A new Non-Governmental Organization that wanted to provide an answer to the daily and haunting problems of people who are socially and economically excluded. A new Non-Governmental Organization that recognized that, even in the bright big European cities, there is another world in motion... a Fourth World.


For 10 years now, the continuous experience of both these people and of the members and volunteers of PRAKSIS is often harsh, and the efficiency of their actions sometimes... debatable, but the lesson that they take with them is substantial and it often actually proves to be fertile.

For 10 years now we are taught, we take our lesson! What is this lesson? One cannot describe the substance of PRAKSIS in only a few lines. However, I will attempt to summarize this lesson as such:

We must be ready to do what others won't. Restrictive measures, bureaucratic restrains, European instructions about closed borders, the various kinds of vested interests – we have to ignore all of these in order to be able to respond to the senseless pain of people in danger.

Charity and philanthropy (which are sometimes used as an alibi) do not solve these problems. We have to intervene in both structures and consciousnesses.

Good will is not enough. Knowledge, experience, method, technical organization, professional consciousness, responsibility, patience and resilience are all needed.



For 10 years now we maintain a firm belief in our duty and our mission. We have a duty to testify to the misery and the pain that infests all our fellow humans who have slipped outside the protective net of social security. Our mission is one of information, transparency and testimony that can eventually transform into an accusation. We have to share all that we see and all that we come to realize with all the people that support and approve of our action. Not to gain accomplices... but to turn them into active participants!

Celebrations and anniversaries are not our specialty. We decided to print this annual action report for a particular purpose: we want more people to know not just PRAKSIS, but who we really are, what we specifically do, the kinds of problems that we face, the kinds of thoughts that we make. We also aspire to find ourselves closer to even more supporters of this idea, this human adventure that we named PRAKSIS (=actions), actions of life.

Because for 10 continuous years the volunteers and members of PRAKSIS are neither distant Don Quixotes, nor a silent minority – an alibi for the consciousness of a passive majority. We are a part of Greek society, an active part that lives through it. The volunteers and members of PRAKSIS come from a common desire, a common vision, and their actions express the best part of each and every one of us!

All these years, the human factor remains for us a relentless conversationalist. It is with him that we have to find the way to conclude our efforts. Besides, all those participating in PRAKSIS (supporters, sponsors, donors, volunteers, members, associates, friends, acquaintances) are nothing if not a real human story.

We address the people around us to help, in unity, other people who are in danger, who are deprived of their fundamental and inviolable rights.

Sometimes numbers speak for themselves. In this annual report we aim to show you how many numbers we "worked" (to use media linguo). We just wanted to demonstrate that with a lot of energy, good will and sometimes with supererogation, we can make the impossible possible.

On behalf of the volunteers, the associates, the donors and especially the populations we serve, thank you very much for your trust in us. And we want to make a small appeal... transfer the idea of PRAKSIS to other people. Become multipliers of this human adventure. It's worth it!

In this annual report that you are holding in your hands PRAKSIS presents a now categorized list of its actions with a strong feeling of accountability and respect towards the fellow human, whom it has been serving for 10 continuous years.

10 years of PRAKSIS Health and Public Heath, because our main goal remains to safeguard the right to health for every human existence independent of sex, gender identity, sexual orientation, religious beliefs, ideology or political orientation.

10 years of PRAKSIS Reception and Integration of our fellow humans who are deprived of fundamental rights.

10 years of PRAKSIS Legal Assistance to demand what is undeniable.

10 years of PRAKSIS for the Child that is in danger, for the child that needs to be cared for, and for the child that needs to experience its own childhood.

10 years of PRAKSIS Volunteering and working action for all of you who have chosen to be our travel companions.

10 years of PRAKSIS Fighting against Poverty by adding a Plus to the Minus (Sin sto Plin) of the economic crisis and creating networks of protection for all our fellow humans who have lived through the consequences of the crisis.

10 years of PRAKSIS Testimony and Advocacy on all levels of national and European political life.

10 years of PRAKSIS collaboration in order to strengthen the voice of society and of its citizens.

Ten years have been concluded, a journey of humanity and offer, a route of exhaustive effort, energy and action, sometimes innovative, sometimes decisive, with plenty of agonies and worries, sometimes with mistakes (because he who works make mistakes), have already created both the consignment of PRAK-SIS and our luggage for a journey that is continuing...

To each and every one of you, to the members that have kept giving the maximum of your effort all these years, to the volunteers that continued participating with zest and loving care in this human adventure that we call PRAKSIS, to our supporters, to our donors, to our communication sponsors that took our message to every Greek family through print and virtual media, a "thank you" is our deepest obligation. Similarly, practical solidarity is our commitment to every fellow human that is suffering. It is our PRAKSIS for the fellow human.





PRAKSIS (PROGRAMS OF DEVELOPMENT, SOCIAL SUPPORT AND MEDICAL COOPERATION) is an independent Non-Governmental Organization whose main goal is the design and implementation of humanitarian programs and medical interventions.

Our main goal is the elimination of social and economic exclusion of vulnerable social groups and the defense of their human rights.

Our beneficiaries are Greek poor, homeless, uninsured, economic immigrants, asylum seekers/ refugees, unaccompanied minors, trafficking victims, sex workers, children begging in the streets, injection drug users, Roma, HIV seropositive people/PLWA, Hepatitis B and C patients, MSM (Men having Sex with Men), prisoners, people released from prisons, Greek families that face the repercussions of the financial crisis, any person that faces social or/and financial exclusion and is deprived of basic goods.

The three axes of our mission are: Prevention, Direct intervention/support, Lobbying and Advocacy.

PRAKSIS implements programs throughout Greece and mostly in Attica, Central Macedonia, the islands of the Northern and Eastern Aegean Sea (such as Lesvos, Samos, Chios, Kos, Leros), Patras area and Northern Greece.

PRAKSIS participates in many secondary bodies in Greece and in a number of networks at the national and European level. Through the implementation of European programs, PRAKSIS also participates in corporate collaborations and networks with other EU members focusing on research, advocacy, exchange of good practices, propagation of information and results, lobbying, divulgation of information and sensitization on different issues, the development of horizontal and vertical information, lobbying and the recording of recommendations, which are oriented to the defense of vulnerable populations, and the promotion of policy changes from public bodies.





OUR ROUTE 10 YEARS PRAKSIS

- 1996 Medicins Sans Frontieres Greece (MSF) creates the first Polyclinic is created in Athens, providing primary medical facilities to migrants and refugees.
 - 1997 MSF opened a second Polyclinic in Thessaloniki. At the same time, a pan-Hellenic research mission takes place, aiming to register the remaining populations that are not included in the social welfare networks and who lack basic medical services.
 - 1998 On the occasion of the voteon the first Presidential decrees, which opens the way for legal counseling of migrants, MSF initiates the Legal Counseling of Migrants and Refugees program (Legal Information Centers) in Athens and Thessaloniki.
 - 1999 Following an initial epidemiological analysis of the medical cases of the two Polyclinics, the Public Health Program begins operating in both cities (Athens and Thessaloniki). Research into the needs and problems faced by Romas in the area of Evosmos of Thessaloniki takes place.
 Volunteers and executives of Athens begin their interventions at the Open Therapeutic Pro-

Volunteers and executives of Athens begin their interventions at the Open Therapeutic Program "Diavasi". Volunteers of the Greek programs participate in providing assistance to victims of the earthquakes.

A research program about the children living on the street of Thessaloniki begins. Its important findings, and the lack of effective interventions, pave the way for the design of a program for this target group.

Research is conducted at the Korydallos Prison in order to investigate and register the characteristics and needs regarding living and health conditions of the inmates.

2001 The "Children the Next Door" program begins.

A program at the Korydallos Prisons begins conducting interventions for health promotion and mobilisation of both inmates and workers through seminars and information on health issues (transmittable diseases and damage reduction from drug use) take place.

In Athens, at the Center of Multiple Intervention of KETHEA (Therapy Center for Dependent Individuals), educational programs regarding reduction of damage from drug use are conducted.



The intervention program at the Korydallos Prisons continues, aiming to deliver speeches 2002 to the inmates regarding first aid, transmittable diseases, reduction of damage from drug use, and re-integration.

The participation in the first cycle of three "Equal" programs is initiated: "Anadrasi-Istos", a program for those seeking asylum, "Nemesis", a program for the rights and the smooth reintegration of inmates and ex-inmates, and "Forum", a program for social cohesion, against xenophobia and racism. The implementation of the Action Plan of Accompanying Support Services also begins: "Productive Integration Space for Migrants and Refugees" (targeting a group of 60 migrants and 60 refugees).

Programs within borders are involved in the informal network for trafficking as well as in 2003 the Greek Forum for AIDS and Mobility. Missions to different points of entry of migrants and refugees take place and legal, psychological and health services are provided.

The Board of Directors of MSF decides to open the debate on the "next day" of the Within the Borders program. The Missions Director is assigned the task of searching for alternative solutions. The evaluation of the Greek programs begins and the mapping of the "landscape" of benefits and programs throughout Greece, for the populations served up to then by MSF, takes place. On the 1stof December, the Public Health Programs organizes an awareness campaign for World AIDS Day.

The internal inquiry and evaluation is completed. In March 2004, the Board of Directors of 2004 MSF receives a proposal for the creation of an independent organization which will include the to-date Programs Within Borders of the organization and will broaden its actions further to other excluded groups.

In June 2004, the General Assembly of MSF decides to "give the green light" to the creation of the new body and approves a lump sum, funding its initiating operations and its sustainability for a year. A letter of the President of MSF, Kostas Papaioannou, announces the new organization named "PRAKSIS" and the new NGO is made public through a press conference.

The total separation of the new body, both administratively as well as organizationally, is decided. Actions will be separate although there is an agreement that, as far as communication is concerned, MSF and PRAKSIS will continue to jointly honor their past accomplishments. In October 2004, PRAKSIS has its own legal charter and is registered in the Athens Court. ... and so PRAKSIS is born!

PRAKSIS had already begun its association with six types of Development Synergies for its participation in the second cycle of the Community Initiative "Equal".

PRAKSIS, now acting on its own, organizes for a second consecutive year, the Campaign to increase awareness and information for WorldAIDS Day.

PRAKSIS participates in certified Development Synergies. PRAKSIS begins implementing the program "STEGI", targeting the new incoming asylum seekers and promoting their independent living in sheltered flats.

The established awareness campaign for World Aids Day is organised.

PRAKSIS is awarded the "Islet of Quality" from "Citizens Society," by the President of the Hellenic Republic, Mr. Karolos Papoulias.

2006 The Reception Center of ex-Prisoners operates in Athens (with its own funding).

The implementation of the Action Plan of Accompanying Supportive Services "PRAKSIS ENTAXIS" begins, targeting 200 individuals (single parent families, inmates, ex-prisoners, migrants and refugees).

The established awareness campaign for World AIDS Day reaches a nationwide span and becomes more complex. Other organizations are invited, and a four-day event attempts to reach out to all ages and levels of the population. The core message of the campaign is: "We stop AIDS, we keep promises, wetake responsibility".

PRAKSIS is funded for the programs of "Children of the Next Door" as well as for the Center of Legal Counseling in Thessaloniki by the Stavros Niarchos Foundation.

PRAKSIS participates in the first directly funded program by the EU, the "Daphne" program, under the name "Act For Children". Together with the General Secretariat of the New Generation of the Ministry of Culture, PRAKSIS implements in Chania and Kos a novel action entitled "My Town on a Bicycle", as well as the original information campaign for youth, "Ask First" ("Prota Rota").

The organization participates in actions relieving fire distressed populations in Ileia and Evoia. Together with the Greek Network for Corporate Social Responsibility, it implements the program "The Next Day".

PRAKSIS is awarded for the second consecutive year the "Islet of Quality" from "Citizens Society" and receives the award from the President of the Hellenic Republic, Mr. Karolos Papoulias.

The largest to date awareness campaign for World AIDS Day is organised, with the slogan "Hugs transmit love... condoms safety".

2008 PRAKSIS now operates eight (8) Core Programs

- 2 Polyclinics: Athens and Thessaloniki
- 2 Legal Aid Centers: Athens and Thessaloniki
- 2 Public Health Programs: Athens and Thessaloniki
- 1 Reception Center for ex-prisoners in Athens
- 1 Program "Children the Next Door" in Thessaloniki

Simultaneously, PRAKSIS implements 18 projects co-financed by Greek Ministries and the EU. A new campaign titled "Ask First" ("Prota Rota") is established as a juvenile awareness campaign by organizing novel events on the occasion of global days, themed evenings and a nationwide campaignduring the summer months.

PRAKSIS receives the first prize at the ACE Awards for the MediaCampaign "Ask First" ("Prota Rota") as an International Volunteering Project in Genova.





PRAKSIS intervenes at the points of entry of Samos islandand Thrace with legal actions and advisory assistance tothird-country nationals.

An informative hotline for Hepatitis B 800 11 11 600 is established. PRAKSIS is a key partner of the EU project "Partnership for a Cohesive Society," which is targetedto encourage and support the participation of all those who have an active role in the social integration of socially vulnerable groups and in the formulation and implementation of policies, focusing the unemployed and working poor; the elderly; female-headed families with children; migrants; and the disabled.

PRAKSIS also implements awareness campaigns for third-country nationals through programs of the European Integration Fund.

PRAKSIS actively implements the pilotprogram "Mobile Information Unit and Testing for HIV", thereby providing anyone wishing to be tested with free, fast and anonymous access to examination.

The PRAKSIS Prevention and Information hotline, 800 11 11 600, is expanded to cover HIV issues as well as Hepatitis B.

As a member of the network Volonteurope, PRAK-SIS welcomes volunteers from around theworld at the "19thEuropean Conference on Education in Voluntary Action", which is hosted in Greece.

PRAKSIS, in cooperation with the NGO ARSIS, initiates the "Mobile School" program, which goes out on the streetsto bring children that lack schooling into contact with various educational activities, with the goal of promoting their access to schools.

Together with "Kentro Zois," PRAKSIS organizes the innovative campaign for awareness and prevention of HIV: "Information-Prevention-Testing: our motto of life".

PRAKSIS continues its interventions and programs at the Athens and Thessaloniki Polyclinics while at the same time expanding its actions at entry and exit points along the Greek border.

PRAKSIS travels to the borders in northern Greece and the Northeast Aegean islandswith its Mobile Medical Units to provide primary health care, social support and legal counseling to newly arrived migrants.

PRAKSIS begins its intervention program in Patras with the goal of providing protection for unaccompanied minors. Specifically, PRAKSIS creates a Day Center of information and support for these children; a "Drop in Center" aiming to identify, inform and connect with them, to provide primary health services, psychosocial care and legal counseling. The main scope of the program is toact in the best interest of the unaccompanied minors who find themselves in

Patras and are in need of international protection. At the same time, PRAKSIS daily street work interventions help identify, informand support unaccompanied minors.

2012 In the context of its Public Health Programs, PRAKSIS implements integrated awareness programs for HIV, Hepatitis B and C. At the same time, it collaborates with hospitals, providing immediate and free referrals for HIV detected cases .At the same time, the free of charge hot line800 11 11 600 continues to inform the public on HIV and Hepatitis B, while also expanding the service to Hepatitis C issues. PRAKSIS also implements an awareness campaign for Hepatitis C.

PRAKSIS begins the implementation of the "SYN STO PLIN" Program. Specifically, it operates two Day Centers for the homeless in Athens and Piraeus. The goal of this program is theirmmediate intervention with those who become homeless. This is anintervention program to handle critical situations within the community, both through the Day Centers as well as through coordinated supportive streetwork interventions.

In addition, and with the goal of aiding Greek families who are being victimized by the crisis and are in danger of becoming homeless, PRAKSIS implements the program "Social Housing" in Athens and Thessaloniki, through targeted supportive actions, aiming at returning these families to the labour market. Specifically, the program aims at the co-ordinated management and support of those families who are at the poverty line, while offering them a series of services and basic needs.



THE HEART OF PRAKSIS

For the last 19 years, without exception, at the PRAKSIS Polyclinics in Athens and Thessaloniki, every person, of whatever population group, can come forward when faced with a problem, whether medical, social, vocational, law or psychological and consult the professionals working for their support and who will do their best to solve it.

The activities of these Polyclinics attempt to ease the social exclusion of socially vulnerable groups and to defend their individual and social rights.

The Polyclinics are the heart of PRAKSIS and are housed in two autonomous sites at Athens and Thessaloniki, where the following services are provided free and without discrimination:

- Primary medical care (General Practice)
- Gynecological follow-up
- Dental care
- Pharmaceutical care
- Psychosocial support
- Employment advisory
- Legal counseling
- Educational and health promoting actions of the supported groups

During 2014 a total of 26,751 patients visited the medical services of the Athens and Thessaloniki Polyclinics. Medical services of the general practice showed the highest rate of use. A large number of patients visited the Athens and Thessaloniki Polyclinic pharmacies in order to obtain free medicines.

From the statistical data we observe a differentiation between the patients having visited the two Polyclinics regarding their population groups, mainly due to their geographical location.

PEDIATRIC CLINIC AT THE ATHENS POLYCLINIC

For the third consecutive year, the Pediatric clinic of PRAKSIS Polyclinic has cared for the needs of children that are not covered by the National Health System. It offers the following services: pediatric examination, follow-up of chronic incidents, medical referrals wherever necessary and examinations for the issuance of individual health cards for pupils. At the same time vaccinations are being programmed for those children that cannot be vaccinated otherwise, thus promoting public health.

Both the doctors and the social service of the Pediatric clinic offer counseling, support and guidance on matters relating to children (social welfare, medical, parent education regarding pharmaceutical treatment, care of sick children), especially for children belonging to vulnerable population groups with specific cultural characteristics.

From 1 February 2014 up to 31 December 2014 there were 1,985 children examined, mostly from Afghanistan, Nigeria and Greece. Finally, 43 children had 57 polyvalent vaccines protecting them from 106 diseases.

The Social Services at the Athens and Thessaloniki Polyclinics at PRAKSIS are the first service that a beneficiary will come across upon visiting the Polyclinics. The staff will receive beneficiaries with the purpose of investigating their requests (medical, social, legal, etc) as well as of diagnosing their pressing and successive problems on time, so as to immediately and efficiently solve them.

The department of Social Services is one of trust in which beneficiaries can deposit their personal stories. The fundamental principle of Social Services staff is to create strong communication ties with the beneficiaries based on mutual trust, so as to achieve the most efficient intervention as possible.

Give a Tablet: Donate the medicines you do not need!

PRAKSIS' ability to provide medicines originates from donations of our fellowmen/women, of pharmacies and pharmaceutical companies arriving at our structures to donate medicines. Even the most common tablets that each of us has at home can make the difference. Sorting out our household pharmacy will benefit many of our fellow men/women.

Social Services staff make sure that beneficiaries are treated individually, taking care to ensure the sensitive personal data of each person. The beneficiaries' situation and requests are registered as a whole and an intervention plan is drawn with their cooperation.

ANNUAL ACTION REPORT | 2014

During 2014 there were totally 12,915 people assisted by the Athens and Thessaloniki social services, of which 1,839 were Greek citizens. This phenomenon continues with Greece being the main country of origin of the beneficiaries visiting PRAKSIS structures in Athens and Thessaloniki, the reason being that unemployment and financial problems continue to influence current reality. Beneficiaries were either not insured or could not afford to pay for pharmaceutical therapy.

The lack of insurance among Greek citizens is due to the following fundamental reasons:

- Their owning property
- Their owing debt to the tax authorities or other insurance fund/scheme
- Lack of unemployment status
- Lack of income tax declaration

The majority of the requests submitted to the social services had to do with financial aid and coverage of the basic living expenses (such as food, payment of bills etc.) To cover these needs, PRAKSIS socials services provided them with psychosocial support, referred them to other services and organizations and intervened with relative departments and social bodies in order to facilitate their access and obtain specialized support.





PUBLIC HEALTH IN ATHENS THESSALONIKI


The Public Health programs in Athens and Thessaloniki aim to promote health and education both for the socially and economically excluded population groups as well as for the general public. These programs are implemented with the cooperation of professionals from various sciences (of a medical, nursing and psychosocial profile.)

Through the Public Health interventions there is an attempt to motivate and increase awareness regarding issues of private hygiene among population groups living in unsafe conditions or on the street. More specifically these attempts include:

- recognizing and registering the needs that come under the sphere of public health at sites with a high concentration of targeted population groups
- improving hygiene conditions in order to reduce the danger of spreading of contagious diseases
- massively informing target groups for prevention methods

Furthermore, through the Public Health programs, a number of prevention and information interventions take place, such as:

- information and examination campaigns for all types of hepatitis and HIV
- informative discussions at schools, prisons, neighborhoods and therapeutic communities for addicts

ATHENS SOLIDARITY CENTER

The Solidarity Center in Athens provides a site for newer and older organizations of the civil society in Greece to operate, facilitating cooperative solutions for urgent social and financial problems in community level. The Center was founded under the initiative of Open Society Foundations and SolidarityNow, in cooperation with the Municipality of Athens and the financial support of European Economic Area Grants, and began its service and the beneficiaries' reception in December 2014. The Center is housed on the first floor of the historical building of the Old Garrison Headquarters in Athens, which the Municipality of Athens offered for this purpose, while SolidarityNow was in charge of the complete renovation of the space that would house the Center's services.

The Center is aimed at all citizens, regardless of nationality, origin or social status and offers its services to all those who may need them. In the Solidarity Center, PRAKSIS implements two programs, MEDICAL SERVICES EXTENDED and EMPLOYABILITY that will both be completed in April 2016.

MEDICAL SERVICES EXTENDED

The MEDICAL SERVICES EXTENDED program is aimed at all vulnerable social groups like the Greek poor, the homeless, the uninsured, economic emigrants, refugee seekers, refugees, individuals with no legalized documents and released prisoners. The services are free of charge to all individuals, regardless of gender, colour, nationality, race, political or religious belief or sexual orientation. One of the main goals of the program is the alleviation of the social and/or economic exclusion of the vulnerable social groups as well as the open and free access to primary health care.

The program is basically an extension of the medical services provided by the General Practitioner, Gynecologist, Dentist and the operation of the pharmacy in the Polyclinic of PRAKSIS in Athens. The fully equipped health clinic in the Solidarity Center of Athens provides both the primary health care and the respective medication when necessary. The specialities of the doctors that PRAKSIS offers in the site of Solidarity Center are the following: Cardiologist, Orthopedist, Dermatologist, Ophthalmologist, Psychiatrist and Nurse. The Social service is comprised of the Social scientists who make the first recording of the social background information and provide personalized and holistic intervention to every beneficiary depending on their request.

THESSALONIKI SOLIDARITY CENTER

Since January 2014 PRAKSIS offers medical services in the Solidarity Center in Thessaloniki within the framework of Solidarity Now, an initiative of Open Society Foundation (OSIFE).

The medical service of the Solidarity Center consists of both salaried and volunteer specialized doctors and includes General Practitioner, Psychiatrist-Psychotherapist and Dermatologist. The general clinic provides primary health care with thorough clinical examination and estimation of the patients' health condition, scheduling and realizing basic laboratory examination when necessary, and planning of the appropriate treatment.

In the psychiatric clinic, the beneficiaries report their request on appointment and then a first diagnostic meeting is held. Depending on the respective needs, the necessary psychometric testing takes place which is followed by a personalized treatment plan that may include consulting, psychotherapeutic intervention and/or medication prescription.

The doctors offer free medication when necessary and keep track of the patients' course of health. In the case of tertiary care, the required procedures for interconnecting the beneficiaries with the appropriate hospitals are held.



In this manner, the populations are tested and at the same informed about the ways of transmission and prevention of the virus, as well as the interconnection and access to cure when necessary.

In 2014 **4.925 individuals** in total were tested in PRAKSIS structures in Athens and Thessaloniki.



The Program Public Health: Prevention, Examination, Support begun in October 2014 and is expected to be completed in April 2016. It is materialized by PRAKSIS in cooperation with the organizations Doctors of the World-Greece, Positive Voice and Center of Life, in the framework of the Program "Increase of Supply of Services of Social Welfare towards Vulnerable Social Groups" Funding Mechanism EEA 2009-2014. The Program is funded by the European Economic Area (Island, Liechtenstein, Norway) through the Bodossaki Institution.

The Program aims:

ANNUAL ACTION REPORT

- (a) at prompt diagnosis of HIV infections and increase of access to medical and psychosocial care for people belonging to groups with high risk of HIV infection and HEP C in Attica and Patra and HIV infection in Thessaloniki and Chania. The examination is carried out in permanent structures and Mobile Units of Information and Examination.
- (b) at the fight against social inequalities and social exclusion through identified actions:
- access to examination and information regarding the prevention of transmission of HIV infection specializing among other things in the transmission between HIV-positive persons but also the groups-communities to which they belong with the aim of altering their behaviour and adopting safe practices.
- consultation regarding the HIV virus after the examination (post-test counseling). Moreover, psychosocial support and legal advice is provided.
- direct liaison (access to public health services) with Special Infection Units.
- awareness of the local community and the broader population in Athens, Piraeus, Thessaloniki, Chania and Patra for the ways of transmission, the importance of the preventative examination, the extinction of discriminations and stigma due to HIV-infection, extinction of social prejudice.

The program is sponsored by Iceland, Liechtenstein and Norway in the framework of the
program "We are all Citizens", which is part of

program is the Bodossaki Institution. Aim of the

PRAKSIS SUPPORT

The goal of the programme is the spherical and holistic approach regarding the support of seropositive people and people living with AIDS (PLWA). The approach focuses on counselling sessions before as well as after testing. The process consists of psychosocial support, legal counselling and counselling on welfare and labour issues. In addition, medical counselling and support with regards to AIDS-related issues is provided. The goal of the process is to support seropositive people and people living with AIDS laying emphasis on their social (re)integration and their functionality at all levels.

The programme is funded by the MAC AIDS FUND of the MAC company for three consecutive years. During the last two cycles of the funding, 639 people were attended to in Athens and Thessaloniki, some of whom are still attended to by professionals who work for the programme. The new participants for 2014 total 303.

Furthermore, in the frame of the programme and thanks to the interventions of social scientists from PRAKSIS, the seropositive prisoners in the "Agios Pavlos" Prison Hospital are also attended to.

391 people were attended to thanks to programme until 31/12/2014.

NSRF IMPLEMENTATION OF A SCREENING PROGRAM -"SERVICES FOR INFORMATION, MEDICAL CARE AND SUPPORT TO TARGET GROUPS" OF ACTION "IMPLEMENTATION OF AN INTEGRATED PROGRAM OF CONTROLLING OF HIV INFECTION IN HIGH RISK GROUPS"

The programme is financed by the Ministry of Health and Social Solidarity in the framework of the European Programme "Development of Human Resources 2007-2013." The aim of the programme is the design and implementation of an integrated programme of control of HIV infection in high-risk groups in the area of Athens. More specifically, timely access to clinical care for HIV-infected individuals, who remain undiagnosed, thanks to the offer of opportunities for diagnosis in the community is the focal point of the strategy to control HIV infection.

In addition, the main goal is the promotion of safer behaviors not only for HIV seropositive individuals, but also for the seronegative individuals of the same high-risk groups. Finally, the awareness and education of health professionals with the purpose of promoting timely diagnosis at the level of primary care, is a basic axis of an integrated programme for the control of the HIV infection.

Specific objectives:

• The design of suitable screening programmes for HIV in specific population groups with an increased probability of exposure to HIV in the area of Athens (immigrants, prostitutes, MSM, clients of the sex industry with multiple sexual orientations, victims of sexual trafficking as well as their clients and promoters, users of intravenous drugs, etc);

- Active discovery and initial inspection in the community of people with high-risk HIV infection and STD:
- Documentation of positive diagnoses and direct liaison with special care centers;
- · Offer of an integrated clinical care package, adjusted to the needs of every target group, and an increase of the percentage of the individuals from the target groups who remain in care;
- The development and application of educational and awareness programmes for the medical and nursing staff with regards to HIV infection and the initial screening with the purpose of HIV diagnosis at primary health care level;
- Information for the prevention of onward transmission of HIV infection and STDs among HIV seropositive individuals, but also in the community groups to which they belong with a view to changing behavior and adopting safe practices (safe sex, periodical check of the HIV status, staying in therapy and under surveillance with the purpose of achieving a non-traceable viral load and, as a consequence, minimising the risk of transmission);
- Information on the prevention of the transmission of HIV infection and STDs in population groups that make contact with high-risk groups and run the risk of exposure (clients of the sex industry, companions of the high-risk groups, etc);





Conduct of a nested epidemiological study with regards to the transmission networks of HIV infection in Greece, as well as the obstacles to take preventive measures and access clinical care for every target group. The aim is to design policies for prevention based on safe scientific documentation.

The design of the programme consists of the following steps:

- Cooperation networking with organisations and groups that are active in the target populations;
- Mapping geographical designation of the areas of Athens in which the target population moves – identification of secret/new spots of activity;
- Assurance of the required authorisations agreements with competent bodies (Municipalities, Prefectures, Ministries) as far as the spots of intervention (squares, stations, parks) are concerned;
- Design and production of informational material;
- Design of the screening programme for HIV;
- Implementation of scheduled street work in the centre of Athens;
- Organisation of mobile units and primary care clinics for examination and counselling for HIV infection;
- Operation of a 24-hour help line for medical counselling on questions regarding HIV infection and STDs for members of the target populations.
- Provision of healthcare and counselling on HIV infection and STDs in an outpatient environment (mobile units, meeting places of the target-population members).

"YOUNG ROMA MEDIATORS ON HEALTH ISSUES"

PRAKSIS, a non-government organisation, implemented the programme "Young Roma Mediators on Health Issues", between February and June 2014 as part of the European Programme "Roma Youth Action Plan".

The target audience of the programme were young people from the Roma community aged 18-30, who as part of the programme were trained to be mediators on health issues in Greece. The curriculum contained desk based and hands-on learning on topics in public health which have been found to be of concern more widely in the Roma communities and camps.

The stages of learning were:

1 st stage: desk based learning to develop knowledge of public health issues

2nd stage: Hands on skill development in the health sector

3rd stage: After both the above stages were completed, three camps/dwelling areas were selected to host information days. On these day, the programme beneficiaries were able to inform and share their experiences and the knowledge on issues pertaining to public health to the wider communities.

PRAKSIS' aim through the programme was not only to educate and develop the skills of the young Roma health mediators, but primarily to facilitate the gaining of knowledge and experience around issues pertaining to public health which are of concern to the Roma communities. In this way, the health mediators themselves can address severe health concerns, finding solutions and coping mechanisms.

While there are several international, regional and national human rights mechanisms in place to monitor and inspect prison conditions – including under the Optional Protocol to the UN Convention against Torture (OPCAT) with National Preventive Mechanisms (NPM), as well as within the Committee for the Prevention of Torture of the Council of Europe (CPT) – issues relating to healthcare, and specifically infectious diseases, are currently not monitoring priorities. Considering prisons represent high-risk environments for the transmission of infectious diseases – especially HIV, Hepatitis C and tuberculosis – this denotes a serious lacuna in human rights-based prison monitoring.

"Improving Prison Conditions by Strengthening Infectious Disease Monitoring" is an EU co-funded project, led by Harm Reduction International, with partners in 7 European countries, aimed at addressing this important gap in prison monitoring practices. The project endeavours to reduce ill-treatment of persons in detention and improve prison conditions through enhanced and standardised monitoring and inspection mechanisms on infectious diseases (TB, HIV and HCV).

The project will map infectious diseases in prisons and current monitoring practices for prisoners' health and human rights in Greece, Italy, Latvia, Poland, Portugal, Spain and Ireland, as well as existing regional and international public health and human rights standards relating to infectious diseases in prisons.

In addition to raising awareness, this mapping will be used to develop a user-friendly tool, including a set of key indicators, to generate better informed, more consistent, and sustained monitoring of infectious diseases in prisons by national, regional and international human rights monitoring mechanisms. Following the tool's promotion and dissemination at national, regional and international levels, it is hoped that it will be widely adopted by human rights-based prison inspection bodies, leading to sustained improvements in prison conditions and overall health in prisons.

Organisations involved in the project are: Harm Reduction International (UK), in partnership with Antigone Onlus Associazione (Italy), PRAKSIS (Greece), Latvian Centre for Human Rights (Latvia), Helsinki Foundation for Human Rights (Poland), University Institute of Lisbon (ISCTE-IUL) (Portugal), Observatorio del Sistema Penal y Los Derechos Humanos de la Universidad de Barcelona (Spain), and the Irish Penal Reform Trust (IPRT).

RECEPTION & INTEGRATION



The Post Release Reception Centre (KYA) supports released prisoners in their transition from confinement to reintroduction. This transition is an especially difficult and complex procedure, since social exclusion is not only intense but is also further negatively strengthened by social stereotypes, stigma and the social and personal alienation of the released.

In an attempt to respond to the increased needs of the specific population group. PRAKSIS runs the Post Release Reception Centre in Athens which operates together with the prison interventions.

The Post Release Reception Centre has set a double target: on the one hand to provide services to the released (psychosocial support, legal counseling, information and primary medical care) and on the other to develop the appropriate networks emphasizing the effective re-introduction of released men and women. KYA's fundamental tools are to approach and tackle the needs of the released holistically and to support their families. This networking also means developing strategic cooperations with respective departments and programs of the local and broader community; their ultimate target being the knock-on beneficial effects in promoting their rights and in satisfying the multiple needs of this especially vulnerable population group.

During 2014, 87 individuals visited PRAKSIS and were informed about the Post Release Reception Centre services. The highest percentage of the beneficiaries was men, from 26 to 50 years old. The beneficiaries' most common requests related to legal, working and medical matters and housing. Their supporting network (family and friends) was rated from inadequate to non-existent.

EUROPEAN INTEGRATION FOUND FOR THIRD NATIONALS

INFORMATION-SERVICE OF THIRD-COUNTRY NATIONALS (TCN)

Action 1.1/12:

"Offices that provide support against discrimination to third-country nationals"

The programme took place between 26/05/2014 - 30/06/2014 and referred to the operation of Special Offices that provide support against discrimination to third-country nationals. The Offices ran simultaneously in seven (7) of the biggest cities in Greece which are the headquarters of the Common Decentralised Administration authorities, in particular Athens, Piraeus, Thessaloniki, Ioannina, Patras, Iraclio and Larissa.

In the Offices, the TCN had access to **personal sessions** through which they received individual administrative support, information, counselling and guidance regarding their rights and obligations as well as the possibilities to deal with discrimination cases against them in the public and private sector. **Group information sessions** also took place within migration groups and authorities activated in the target-groups with the purpose of informing as more third-country nationals as possible.

In total, 1.734 third-country nationals benefited through personal as well as group sessions. However, 3.596 people benefited shall we count their family members who indirectly benefit from this kind of interventions.

HOUSING



Since 2005 PRAKSIS offers independent and temporary accommodation to newly-arrived asylum seekers through STEGI program. In 2014 the 9th funding cycle of STEGI program was completed and the 10th has begun with STEGI I' program which is to be completed in February 2015. In 2014, PRAKSIS has operated twenty five (25) apartments: nineteen (19) in Attica, four (4) in Thessaloniki and two (2) in Mytilene.

These apartments are autonomous and leased by the organization and offer accommodation to people who had recently left their country in war zone or were forced to abandon their country due to violation of fundamental human rights. In accordance with the capacity, in the apartments stay more than one family. However, the ethnic origin and the beneficiaries' language are taken into consideration in order to avoid any conflicts and ensure a smooth cohabitation.

The cases to which the Center provides housing include the most vulnerable. Unaccompanied mothers, single-parent and large families, transgender individuals, certified torture victims and people with chronic health problems.

Through temporary housing, PRAKSIS aims at providing the beneficiaries with the necessary safety in order to prepare and equip themselves towards their autonomy and integration to the Greek reality. At the same time, in contrast with other accommodation types, the apartments do not lead to institutionalization since they provide autonomy and independence to the beneficiaries. Nevertheless, while the beneficiaries of the program stay in an apartment, PRAKSIS interdisciplinary team consisting of Social Workers, Psychologists, Social Mediators, Social Anthropologist and Lawyers covers a wide range of needs (legal, psycho-social, work etc.) either internally in other PRAKSIS programs and actions or through the interconnection with a related network of specialized and competent institutions and individuals.

The program's ultimate objective is making the beneficiaries autonomous as soon as possible and integrating them in the Greek society.

IN THE YEAR 2014:

- 220 asylum seekers have been accommodated in the program. More specifically, 88 of them were men, 45 were women and 87 were children.
- Among them were 8 certified torture victims, although many more have reported abuse in their country of origin.
- 22 individuals with severe disabilities, two of them having mutilated their legs. Also, other cases with severe health problems have been accommodated.
- DONATIONS: For the coverage of the beneficiaries' needs of STEGI program, 106 donation requests have been realized in many companies.

In 2014, STEGI program accommodated 220 individuals who came from 24 different countries of origin. In STEGI program over six different languages are spoken, while the larger proportion of the beneficiaries is comprised of young people aged 26 to 50 years old.



EMPLOYABILITY





In the framework of this program free services of supporting the unemployed in job search are provided in Greek, English and French. The services of employment consulting, job search in Web under the assistance of specialized consultants, group workshops, seminars and networking actions aim at maximizing the potential of the unemployed from vulnerable social groups towards their integration in the job market. Additionally, the innovative element of Employability is the web-based network platform of the beneficiaries with companies that participate via the familiar programs of Corporate Social Responsibility.

The employment consulting services address all the social groups who undergo discrimination and face severe obstacles in having access to the job market like: the long-term unemployed, new entrants in the job market, parents of single-parent families, unemployed of low qualifications, unemployed women who face additional social obstacles in their integration in the job market, immigrants, refugees, repatriated immigrants, roma, unemployed who face conditions of multiple exclusion due to age, health, gender, sexual orientation, cultural identity, difficult financial conditions etc.

The main goal of the Program is reinforcing the potential of integration in the job market of 1.500 unemployed from the Vulnerable Social Groups through the employment services offered, which include:

- Provision of employment consulting and the necessary tools for successful job search, which include:
 - Analyzing professional interests
 - Creating CVs and Cover Letters

- Learning job search methods
- Preparing for the job interview
- Consulting of vocational guidance
- Supporting in filling out job applications
- Access to job search services though Web via the internet corner booth of Employability Center, with the assistance of specialized consultants.
 - Use of the job search web-service, on appointment, with the assistance of a specialized consultant.
- **Update** on new job positions and training programs
- Workshops of group employment consulting and skill development for the reinforcement in job search
- Interconnection of the unemployed with the companies via the web-based platform of PRAKSIS Employability which was specially designed to promote the beneficiaries' integration in the job market
- **Post of CVs** in the web-based network platform ensuring the confidentiality of the personal data
- Promotion of PRAKSIS Employability platform in corporate environment and including the staff recruitment procedures in the Corporate Social Responsibility programs of the participating companies, in order to reinforce the absorption of the social vulnerable group in new job positions
- Networking actions with agents of employmentissues promotion and companies of the public and private sector
- Reference to specialized training organizations for the reinforcement of professional and educational skills

During the period that the program was realized in 2014:

- 27 beneficiaries in total were served
- 45 sessions have taken place
- 5 sessions regarding internet access were realized
- 38 sessions of employment consulting have taken place
- 27 Holland tests have been filled in
- · 10 CVs have been prepared





The PRAKSIS Business Coaching Center (BCC) is a new initiative launched in 2014 by PRAKSIS aiming to support the unemployed from socially vulnerable sectors by helping to get them back into meaningful employment, specifically self-employment.

Our funders for the first year are the JPMorgan Chase Foundation and the US Embassy in Athens. The Foundation works to support initiatives that promote the development and growth of small businesses and social enterprises to create jobs. The US Embassy shares our belief that encouraging entrepreneurship and the creation of sustainable enterprises, will help stabilize the Greek economy and help individuals, families and the local economy to grow.

The program welcomes any willing supporter and encourages synergies in order to fortify its sustainability. Therefore, BCC is already supported by AMKE VAPORI, and collaborates with Modelez Hellas and Panteion University.

Scope of the program

Medium sized enterprises.

The scope of the program is to empower aspiring entrepreneurs to establish viable business ventures and contribute to the economic development of a region. According to research published by 'K' on 12.10.2014, the majority of enterprises which were founded in 2014, were restaurants, cafes and canteens, most of which have already closed shop. Contrary to these trends, the PRAKSIS BCC focused on supporting businesses from a variety of different sectors:

- Design and creation of accessories (leather handbags, wallets, cases etc)
- Woodcraft: creation of goods out of wood including mirror stands, vases, etc
- Music / Sound studio
- Learning and relaxation center for the parents of autistic children
- Design and creation of children's clothes
- Creation of a website (platform) for the promotion of Greek fashion & clothing
- Martial Arts School
- Creation of documentaries for the cultivation of Goji berries Greece
- Children's puppet theatre
- Soap handcraft from extra virgin olive oil and all natural produce
- Carpenters Workshop

CSR Programs

Large companies from Greece and abroad have the opportunity to support the efforts of the PRAKSIS Business Coaching Center and its graduates through the program by "adopting a business". An activity that supports the whole spectrum of their CSR program, including economic support in the form of seed capital, in-kind donations like furniture and other equipment or products, or volunteering personnel support from their human resources (legal expert, accountant, IT support etc) to new entrepreneurs. Our support to our entrepreneurs continues after their graduation from the PRAKSIS BCC through mentors, companies and other organizations that believe and support our cause. Such an example is the NGO Desmos which intervened so that We Create Harmony could help two of our participants to further develop their businesses by providing the necessary equipment to improve their work (including a professional sewing machine for sewing textiles, a shearing machine and a Dremel multi-tool for woodcraft).



TOPEKO, the local actions of social integration for vulnerable groups, are implemented in the framework of Action 3: "Local actions of social integration for vulnerable groups" of Intervention Category 1: "Preventing and combating social exclusion experienced by vulnerable population groups" of the Thematic Priority Axis 4: 'Full Integration of all Human Resources into a Society of Equal Opportunities' of the Operational Programme «Human Resources Development 2007-2013" that is co-funded by the European Social Fund (ESF) and the Ministry of Labour, Social Security and Welfare. It is a Public Expenditure Programme funded by Community and National Resources of the Public Investment Programme.

The implemented programmes aim at the attraction, selection, preparation and promotion of employment among the unemployed at local level through the creation and operation of social cooperative societies, individual enterprises and job positions in existing businesses.

The programme is addressed to people who are unemployed, registered in the unemployment records of OAED (Labour Employment Office) and who belong to socially vulnerable groups. Beneficiaries are given the opportunity to:

- acquire the main professional skills required in their fields of training;
- develop professional skills in new subjects;
- be integrated in the labour market by acquiring additional communication and social skills.

The implementation of the programmes consists of:

- actions of training Vocational training;
- training in topics of entrepreneurship and social entrepreneurship;
- internship programmes;
- development of business plans for the opening of individual enterprises and social enterprises by the beneficiaries:
- information and support of the beneficiaries regarding possible sources of financing, procedures for starting up their businesses, access to the labour market, etc:
- networking with other professionals and counsellors/experts;
- psychosocial counselling;
- professional counseling;
- development and promotion of partnerships

LEGAL ASSISTANCE



The Legal Aid Centre chiefly aims to provide free legal counseling to economically and socially excluded social groups living in the greater areas of Athens, Thessaloniki and Patras (areas in which PRAKSIS is active) and who are facing legal problems.

PRAKSIS provides legal counseling for matters relating to the legalization procedure of third country nationals, as well as other issues (for example work, family and debts) depending on the specific needs and the population group to which the person seeking aid belongs.

The Legal Aid Centre beneficiary groups are: asylum seekers/refugees, financial migrants, Greek poor, homeless, uninsured as well as any socially excluded population group such as addicts, gypsies, trafficking victims, released from prison, street children and all those fellowmen and women who lack access to legal support services.

FOR CHILDREN



aving become aware of the constantly increasing phenomenon of child labor — a phenomenon inextricably connected to the current crisis and poverty — and attempting to contribute to its elimination, PRAKSIS implemented the structure of "Next Door Kids" at Thessaloniki.

In this structure's context, PRAKSIS implements the program "Mobile School". Since October 2009, PRAKSIS has at its disposal an innovative tool aiming to approach, assist and finally reintroduce children faced with child labor as well as their parents. The program and the homonymous tool is the Belgian association "Mobile School"; the program is implemented in cooperation with NGO ARSIS.

More specifically, a group of specially trained volunteers of a various science background — social workers, psychologists, teachers — approaches the populations through weekly visits to camps and ROMA settlements at Thessaloniki and works on three axes:

• Work with the children. The group works with the children on two levels: at first on the educational, where the learning level of the children is increased so as to prepare them for the school environment. Secondly at the psycho-sentimental level, at which the children are prepared to be introduced to society in the broader sense. In order to succeed in both these, the group aims to increase the children's self-esteem through therapeutic games, educational activities and positive feelings of trust created between the children and the educators.



- Work with the children's families. The group approaches the children's families, listens carefully to their needs and attempts to connect them with other community bodies so as to immediately and fully cover their basic needs, as far as possible.
- Campaigns and happenings to inform and increase awareness in the broader community on the phenomenon of child labor. The happenings aim to inform and increase citizen awareness of child labor and the situations that these children are faced with, so as to mobilize them to become involved themselves in fighting this phenomenon.

RESULTS

During 2015, the Mobile School carried out a total of 45 interventions at the Dendropotamos settlement and at Peraia camp, at which 156 children participated actively.

rom the start of the Social Housing program "Sin sto Plin" the need to cover extra-curriculum lessons as well as a broader educational background for the children of beneficiary families was observed.

Through the initiative "Efodia Zois, Vimata Zois" and with the funding of Roche Hellas SA, PRAK-SIS undertook to cover the learning and broader educational needs for two years for at least 400 children. The program is targeted exclusively to families hit by the current financial crisis that are unable to cover the increasing educational needs of their children.

Specifically, the program is targeted to families living in Athens and Thessaloniki for the period from March 2014 to August 2015 and amongst others covers the following:

- Fees for foreign language and secondary level extra-curriculum classes
- Foreign language learning books
- Extra-curriculum classes books

- Foreign language examination fees
- Student benefits for children studying away from their parental town
- Other educational needs

Furthermore, the program covers educational activities targeted to broaden the children's knowledge. Specifically, the following activities are implemented:

- "Lending Libraries", an activity dependent on the collection of books and the creation of libraries operating at PRAKSIS structures all the year round. The first library at the Athens Homeless Day Reception Centre has more than 1,500 Greek and foreign books. In this way both the children as well as the families of the program can acquire immediate access to knowledge.
- "Evening Readings" during which the children of the program have the opportunity to engage in creative activities.
- "Cultural Routes" through which the children of the program have the ability to visit museums and other cultural and educational sites for the whole of the program's duration. The program is an innovative approach to interactive education through suitably designed seminars and other activities.

Integrated Corporate Social Responsibility (CSR) Program

This program is an integrated activity in the context of CSR; the human resources of the company funding the program are directly involved in a series of activities. Employees are invited to take part in an innovative Awareness Seminar run by PRAKSIS and an individual voluntary work program; they are also invited to participate in all the educational and training programs and in the monthly collection of various basic items such as medicines, food, clothes, etc.

Reflecting the needs of the immigrant population in Patras and mainly the needs of the unaccompanied boys in the region, the Drop-In-Center first opened its doors in August 2011. It is a Day Center, open to unaccompanied minors from third countries, minors who are separated from their parents and need international protection. The interdisciplinary team which staffs the Drop-In Center consists of social workers, psychologist, doctor, lawyer and social mediators.

The aim of the program is twofold: on the one hand, it aims at developing and promoting measures for handling the protection needs through services of reception, counseling and referring the unaccompanied minors to the right protection mechanisms. On the other hand, it aims at detecting significant deficiencies related to aspects of the unaccompanied minors' protection as well as the promotion of good practices. Therefore, the methodology is applied in accordance with the special needs of this group of the immigrant population.

In respect of the unaccompanied minors' needs which the professionals of the center are called to address are the following: healthcare, legal counseling, advocacy of the beneficiaries before authorities and other involved entities, their social interconnection with their families, the provision of psychosocial support, unhindered access to the National Healthcare Service (ESY) and the Asylum Support Office, interconnection and interaction with the Community as well as the provision of humanitarian aid via meals and essentials, like toiletries and clothing.

In the Drop-In Center, the beneficiaries can use computers, have access to the Internet, call their families, participate in creative occupation, like the teenagers team, attend English and Greek language lessons, take a bath, visit the doctor, consult a lawyer and be psychosocially supported over issues that may concern them.

The overwhelming majority of the beneficiaries are boys aged 15-17 years old who come from Afghanistan, a fact which seems to be representative of the overall profile of the migration phenomenon in Patras. Among the population served are also minors under 12 years ago. These are highly vulnerable cases. The social workers of the Day Center approach these cases on the basis of the minors' best interests, progressively develop a relationship of trust with them through theatrical games and experiential exercises so that they gain their consent and get integrated in the protection mechanisms.

Main goal of the program is the investigation of the minors' family background in order to find if there is a family link in any European country and the information of the procedure of family reunification according to the Dublin III regulation.

The operation of the Accommodation Center STEGI PLUS (+) has played a key role in the approach and protection of unaccompanied minors who live in homeless conditions. Main objective of the Accommodation Center is the cyclical intervention. The Drop-In Center helps locate the minors and acts as a transit point. It receives the unaccompanied minors who try to leave illegally and reach their destination. For each case we individually approach and examine their social background as well as offer them the alternative to be integrated directly in the Accommodation Center.

Additionally, it is Drop-In Center's priority to intervene in matters of minors' custody. It collaborates with all the involved entities in order to expedite the procedures and the minor in custody be sent to a safe and appropriate environment.

The unaccompanied minors or minors separated from their parents who were recorded and supported by PRAKSIS (Drop-In Center in Patras for the time period January – December 2014) amount to a total of 500 children.

One of the primary actions of the Drop-In Center team is streetwork. Streetwork aims on the hand at identifying unaccompanied minors and their living conditions, and on the other hand effectively familiarizing them with the Day Center facility for the issues that concern them. The team that goes out for streetwork consists of social scientists and social mediators. A typical example of streetwork is the case of an 8year old unaccompanied minor from Yemen. The child was referred to the Accommodation Center and the procedure of family reunification with his father began.

Another main element of the program's operation is networking with the local authorities, other organizations and entities. In order for the intervention to become more effective and achieve a holistic management of the cases, cooperation with other organizations on a national and international level as well as with the local authorities is necessary. In this manner, the current phenomenon is identified and recorded in detail and the effective observation of the cases is fostered, focusing on the best interests of the minors.

More specifically, we maintain a firm and effective cooperation with the Juvenile Prosecutor and operate a 24hour hotline for intervention and support. When an unaccompanied minor is identified by the port or police authorities, upon oral court order, the social worker and the social mediator perform intervention on the spot. Main principle of the program is servicing the best interests of the children. For this reason, each child is individually handled according to the vulnerability of the case, the desires and the specific needs of the person. In this framework, a protection mechanism is mobilized via accompanying the children, temporarily housing them and referring them to appropriate accommodation centers.

A typical example is the case of a 5year old boy from Syria who was located by the port authorities inside a suitcase. We offered him temporal and urgent accommodation in order to investigate the present situation as well as search for any family members.

The aspiration of the interdisciplinary team of the Drop-In Center in Patras is the reinforcement of its potential, the enrichment of its experience and intervention tools. The vision and source of inspiration is for the team to become an agent of substantive changes in the field of unaccompanied minors' protection as well as ensuring and developing more humane living conditions. Our aim is to bring out the phenomenon and establish a common practice for dealing appropriately with the unaccompanied minors.

Part of the services of the Drop-In Center in 2014 was funded by IOM of Italy with the program 'PRUMA «PROMOTING FAMILY REUNIFICATON AND TRANSFER OF UNACCOMPANIED MINOR ASYLUM SEEKERS (UMASs) UNDER DUBLIN REGULATION» with the main goal to consult for standard operating procedures (SOP) that will contribute to expedite the procedure of family reunification (on the basis of the Dublin regulation), from locating the minor to transferring them in front of the European state, where the family member is, taking into account the minors' best interest and the legal guarantees on which the interest is based.

PRAKSIS operates as a focal point for Greece and CIVICO ZERO for Italy respectively, aiming at the identification, the psycho-social and legal support during the whole process of the minor.





The program concerns the operation of Accommodation Centers aiming at providing housing to unaccompanied minors as well as other vulnerable refugee seekers (like single-parent families, vulnerable women etc.) The services provided to all population groups along with housing are:

- psycho-social support
- medical and nursing care
- · mediation services
- legal counseling
- Greek language learning programs, creative occupation, supplementary teaching for the minors and organizing intercultural events
- coverage of basic survival needs, food, healthcare, security, education
- job support to vulnerable groups,
- education/training/vocational guidance for the unaccompanied minors
- personal care services

The program operates in Athens and Patras. The Accommodation Center of Athens provides housing to thirty (30) unaccompanied minors and the Accommodation Center of Patras provides housing to thirty (30) unaccompanied minors and forty (40) vulnerable groups of refugee seekers.

The program operates under a corporate entity which consists of:

- NGO PRAKSIS (coordinator of the corporate entity)
- and the HELLENIC RED CROSS (associate)

In Athens the management of the Accommodation Center located in Skiathou Street 89 runs under PRAKSIS responsibility (the RED CROSS coordinates the educational activities of the children) and in Patras PRAKSIS coordinates the activities for the unaccompanied minors while HELLENIC RED CROSS coordinates the activities for the vulnerable populations.

he aim of the program through the operation of the Accommodation Centers is multidimensional, the backbone being the reception and integration of the unaccompanied minors who are in custody as well as the unaccompanied minors who experience homeless conditions and live in substandard conditions, like abandoned buildings.

Another central point is the coverage of the population's needs as well as the personalized intervention on the basis of the child's best interests. The long-term objective is the minors' adaptation and integration both in the Accommodation Center and the host country in general. The integration process is gradual and this is why the intervention pertains to individual, group and community level.




The unaccompanied minors are a highly vulnerable population group. These are children who lack of family unity. They have left their country of origin due to hazardous and inappropriate conditions, like conditions of general violence, and then arrive in Greece and keep being exposed to danger like their precarious transportation, exploitation, lack of any protection mechanism.

The staff of the Accommodation Centers consists of social workers, psychologist, lawyers, doctor, nurse and social mediators. The central goal of the interdisciplinary team is the smooth integration, the minor's adaptation, the evaluation of the present situation as well as the cyclical intervention by all specialists.

The total number of unaccompanied minors accommodated in the Accommodation Center of Athens during 2014 is one hundred thirty three (133). Below statistics of their countries of origin are listed.

COUNTRIES OF ORIGIN ATHENS





Particular emphasis is given to the action of legal counseling in order to investigate the family links and obtain information regarding the procedure of family unification according to the Dublin Regulation III.

In 2014 there was the total of six hundred sixteen (616) references to public and private entities realized in Athens and Patras so as to serve the minors' requests. In the framework of bringing the minors in contact with the community, we develop community activities aiming at the interaction of the local society and the beneficiaries' involvement in it.

With regard to the activities, we have developed a network of collaborations so that the minors can develop their interests through their occupation with different subjects like basketball, volleyball, chess, theater, handcraft, dance, music, football, bowling and visits to places of interest like the Organization Earth, Acropolis Museum, Allou Fun Park, Attica Zoological Park, Genadios School, Adventure Park, Cirque du Soleil and Planetarium. The Municipal and Regional Theatre of Patras accepted the request of the Accommodation Center for Unaccompanied Minors seeking refuge and Vulnerable Populations «STEGI PLUS(+) Patras» and created a theater division for teenagers who live in it as well as decided to create an Intercultural Workshop for Teenagers aiming at the adaptation, integration and interaction of children between 13 - 17 years old through the theatrical action. In the Intercultural Workshop for Teenagers, apart from the beneficiaries of the program «STEGI PLUS(+) Patras», any teenager of the city can participate,

free of charge, regardless of their country of origin. The participants get to know each other, express their selves, improvise and interact by using the theater's language.

In the accommodation structure of Athens minors can attend supplementary teaching, lessons of Greek, English, Dutch, Norwegian and German, computer lessons and creative occupation class. Our aim is to integrate the unaccompanied minors in the Greek society and not just include them in it. This is why we believe that learning the Greek language and getting to know about the culture of the country contribute significantly to this objective. Consequently, by registering the minors in intercultural schools, through the supplementary teaching of Greek by volunteers and the visits in museums and art sites, we promote the Greek spirit, and prepare them to face the demands of their adult life.

In STEGI PLUS (+) we embrace their worries and anxieties for a better future, providing them with the warmth of a home and giving them the love and care they are deprived of from their direct family environment. We support their dreams by taking part through our personal support to the accomplishment of what is a moral bet to all of us.

With STEGI PLUS (+) we have an open embrace and give our hearts as a home to all those heroes-in-life who teach us that we can become superhumans.



ADVOCACY





European Parliament:

In view of the upcoming EU elections, PRAKSIS has the opportunity to express its stance on fundamental social issues in a series of conversations with MEP candidates of various factions. It participated in commissions taking place in the offices of the Eu Parliament in Greece (e.g. conference on the tragedy in Pharmakonisi and Lambedouza, on violence against women, on the increase of poverty indicators and the consequences on Greek society from 2010 onwards, etc.). PRAKSIS participated in open conversations in the European Parliament (e.g. in "Europe, make it fairer" about the obstacles in accessing public health services and in "Can we afford our medicines?" about the abolishment of restrictions in accessing medicines).

Regional administration/ Municipalities:

After the regional and municipal elections, systematic communication was established with the new Mayors and ... of areas where PRAKSIS is developing programs and structures to support vulnerable populations. The result is cooperation with local bodies for the operation of new premises (e.g. in Athens, Thessaloniki and Patra), as well as the continuous collaboration on issues of lack of housing in times when bad weather conditions raise additional problems to people that live in the street.

Semester of Greek Presidency of the E.U.:

PRAKSIS participated in a closed meeting organized by the ECDC (European Center for Disease Prevention and Control) along with Hellenic Center for Diseases' Control (KEELPNO) regarding the health service checks on migrants in detention centers. The representatives were given the opportunity to express their disappointment about the detention conditions and to draw attention to the fact that detainees should have the option to not be examined for certain infectious diseases (opt out testing).

PRAKSIS also participated in the HIV MEDIA CLUSTER organized by KEELPNO and the European Commission. It was given the opportunity to point out the extent to which the YC39a constitutes a violation of human rights, as well as to point out the failures of political leadership regarding the deficient implementation of policies on damage control.

Furthermore, PRAKSIS organized a conference in collaboration with Greek Platform for Development -under the auspices of the Greek Presidency of the E.U. - on the subject of "Democracy and Development: good practices of cooperation among the states and civil society". This has been an excellent opportunity to share good examples of collaboration and to organize a workshop by the Pompidou Group concerning the situation in Ukraine in the aspect of people who use drugs and their access to Opioid Substitution Treatment, after the conflict with Russia.

Civil society collaboration platforms

During 2014 PRAKSIS has strengthen collaboration with civil society in a broader sense, having as core belief that common activities and advocacy efforts do matter and can make a difference.

On a Greek level PRAKSIS was active in many of the activities of the Hellenic Platform for Development, in Poverty and Housing Networks, worked together with other organizations on public health issues (prevention and awareness) and was one of the founding members of the Hellenic platform on psychoactive substances. PRAKSIS participated in all meetings of the Health Commission of combating HIV/AIDS epidemic among drug users (that was set by the Greek Ministry of Health under ministerial decree).

On a European Level PRAKSIS was part of the Board of Directors of FEANTSA and part of the Steering Committee of AIDS ACTION EUROPE. PRAKSIS was officially recognized as member of the EU HIV/AIDS civil society forum, member of the task force of CONCORD on migration issues representing the Hellenic Platform of Development and was appointed as focal point of the EuroHRN concerning south Europe region.

Missions:

On March 2014 PRAKSIS along with other Greek organizations and public institutions has been part of the joint mission to Finland. This mission was under the auspices of the ECDC and aimed at visiting Finnish premises that promoted harm reduction policies that managed to control an HIV/AIDS epidemic among drug users in Helsinki 10 years ago. As the economic crisis brought many representations of International and European Institutions in Greece in order to monitor closely the results and effects on economy, housing and public health, PRAKSIS worked closely with The Human Rights Watch (HRW), Correlation, International Drug Policy Consortium (IDPC), Trans Atlantic Consumer's Dialogue (TACD), ECON MePs etc, supporting with data and experience directly from the field.

Annual Reports / Contribution to mission reports:

PRAKSIS has contributed with data to the annual report of ECRI (European Commission against Racism and Intolerance), to the annual report of the Human Rights Watch (HRW) and to the national report on HIV/AIDS issues written by KEELPNO.

Conferences and open discussions:

PRAKSIS has participated in many congresses in Greece (political, social, institutional, scientific, medical, etc.). It was invited to shape the economic crisis effects in different working bodies and workshops and has attended conferences on medical, communication, scientific and political issues.

PRAKSIS has participated also in different congresses abroad on poverty, vulnerable groups, public health and access to medicines, etc.

Patient groups' empowerment:

PRAKSIS' close collaboration with several patient groups has been developed as an interesting way of sharing knowledge and tools towards the empowerment of patient associations in different levels such as organizational, fundraising, advocacy, communicational, etc.



SUPERVISION
OF OBSTACLES OF ACCESS
TO PUBLIC HEALTH
FACED BY PATIENTS
WITH HEPATITIS C

RAKSIS has been offering for many years the possibility for free of charge, fast and anonymous examination for hepatitis C. At the same time, it offers legal and psycho economic support to people who have been diagnosed with HIV/AIDS and/or hepatitis C. Hence it is constantly in contact with patients who have hepatitis C. In view of the entrance of new "weapons" in the scientific quiver that is, innovative medication regarding which the production and distribution companies talk even about eradication where viral hepatitis is concerned, but also taking into consideration the effects applied politics have had on the health domain over the past 4 years, conducting a research with patients suffering from hepatitis C seemed extremely important. The aim of the research was to record and monitor the obstacles of access to the health system, diagnostic examinations and existing treatments.

In the summer of 2014 in cooperation with the University of the Peloponnese (under the HOPE research framework) a research tool that was applied pilotically to 101 patients with hepatitis C was created (beneficiaries of the services of our organisation).

The results were announced at the 2nd Interscientific meeting for AIDS and Hepatitis. Among the most important findings of this research it is worth noting the following:


- 4,6% of patients didn't manage to find their medication in a public hospital
- 36,6% didn't have access because they were uninsured
- 57% missed or were late for treatment based on the doctor's recommendations
- 36% had to ask for treatment for a few days from others

Among those who were late or missed their treatment:

- 55% their health condition worsened
- 45% had to be hospitalized

This research tool remained at the organisation's disposition for the continuous supervision of patients with hepatitis C while, as a result of this research there was a processing of recommendations towards the Ministry of Health and the competent authorities for the improvement of access to diagnostic examinations and treatment.










The way public figures refer to HIV/AIDS-related issues in different occasions still raises questions. Science has made big progress leaving behind old decades and their obsessions or ignorance permanently. However, even nowadays, public figures choose to use - willingly or unwillingly - the word "infection" targeting people and well as reinforcing stigma and social exclusion. To that end, PRAKSIS, Positive Voice (coordinator of the programme) and Centre for Life developed a coalition with the purpose of processing and implementing a programme the goals of which are the following:

- to control the social stigma with which people living with HIV/AIDS are faced,
- to defend their rights and make them more visible in public life,
- to raise awareness and train the main policy-makers and influencers of the public opinion (the Hellenic Parliament, local government and mass media).

During the first months of the programme (autumn 2014), a monitoring system was put in place which followed what was publicly said about the topic. Evaluation and coordination meetings took place every two weeks among the partners, while open letters and press releases were issued to journalists and members of the Parliament who took a stand or wrote an article about the topic in a non-rationalistic way. At the same time, in the presence of representatives of the local government, the opening press conference took place.





OUR ROUTE

AGAINST POVERTY



In 2014, Greece was the country in the Eurozone with the highest percentage of its population facing the danger of poverty or social exclusion (35.7%); at the same time unemployment remained at especially high levels (26.5%), even though it was reduced relatively to 2013.

This was also the year that began with a primary surplus, the year that the Guaranteed Social Revenue program was implemented on a pilot basis (two years after the relevant Government Gazette – FEK – had been issued) and the year that the Partnership Agreement 2014-2020 was approved; it was also the first time that calls for implementing programs for the homeless were published.







PROGRAM DESCRIPTION THE INITIATIVE

The Program "Syn sto Plin" is an innovative and unique initiative by Greek standards, designed jointly by The Stavros Niarchos Foundation (www.SNF.org) and PRAKSIS.

Programs such as Social Housing focus on providing economic support and counseling, aiming directly for each family to preserve their financial and therefore their ekistic independence. The program's main target in the medium term is to give families the ability to live without requiring external assistance. On the flip side of the same program, the operation of the Day Centre chiefly provides relief. The program contributes to the relief of an especially vulnerable population group experiencing the effects of the crisis intensely and harshly on a daily basis.

SOCIAL HOUSING

With political instability remaining a fundamental characteristic of the economic and social scenery within 2014 and poverty reaching out to an increasingly large part of the population, the program of Social Housing was duly implemented in the first quarter of 2014; it was evaluated externally in the second quarter and redesigned to be finally tested in parallel with the program of Guaranteed Social Revenue. The implementation of the latter began in 13 municipalities all over the country on a pilot basis in November 2014. So, during the third quarter, and specifically since August 2014, the third cycle of the Social Housing program continued.

This was implemented using economic benefits In line with the respective ones provided in the Guaranteed Social Revenue program as well as all its accompanying services of the previous two cycles.

During 2014, a total of 743 new families were integrated in the program, while 127 families continued from the previous year. The characteristics of the integrated families as well as the program results are referred to in detail in the data below. However, it is typical that the deep recession being experienced in Greece is also being clearly depicted in the dramatic reduction of revenues of the families integrated in the program; at the same time they are faced with the increasing difficulty to be able to autonomously balance their debts with daily living expenses.

The two previous cycles of the Social Housing Program were evaluated by an external auditor. Despite the unfriendly external environment in which the program was implemented, it proved that a holistic, individualistic approach can undertake the role of an efficient and effective safety net to a fragile social network.

From March 2012 up to March 2014 the program supported 2,373 families, 68% of which were absorbed in the labor market while 44% remained in the labor market a year after completing their participation in the program.

HOMELESS DAY CENTRES - ATHENS - PIRAEUS

During 2014 there were **53,498** visitors at the Athens and Piraeus Homeless Day Centres, of which the newly registered individuals and families were **1,705**.

Since the beginning of their operation in May 2012, the Athens and Thessaloniki Homeless Day Centres have serviced 5,479 individuals and families for more than 112,000 visits.

During this year social services conducted 5,969 individual interviews.

The main requests still have to do with housing, legal aid, medical follow up and referral to organizations capable of covering more complicated medical issues, professional counseling (all beneficiaries are unemployed) as well as psychological support.

The referrals which had to do both with the relative requests and with escorting or visiting beneficiaries during hospitalization, reached 1,806.

Beneficiary average age was around 40 years (a mean of 39.17) while the countries of origin were more than 70. The highest percentage among beneficiaries were Greeks (30%) while second were Afghan citizens.

Satellite services

The character of the Athens Homeless Day Centre has been enriched by the services supported by volunteers, companies, organizations and foundations. Typical examples follow:

• The Wardrobe: The ability to provide clothes is totally dependent on all those who regularly fill the SYN STO PLIN boxes at the outlets of PRAKTIKER company and on all those volunteers who constantly clear and tidy all the arriving clothes so as to offer them to those in need.

- Children's Corner: It was originally created with the support of PRAKTIKER and volunteers. Lately it has been improved with the assistance of Mondelese company. It continues to be supported by volunteers every Tuesday and Thursday, the days that the Centre is open to families.
- Lending Library: It started by book donations to the Centre by individuals; it acquired heart and character when a volunteer who initially offered to help register and record them began organizing discussion groups of essays or books. It has recently been strengthened by ROCHE and is now hosted on the fifth floor, every Wednesday and Friday.
- Film Club: Film shows began by the keen interest of a volunteer to provide some relaxation after the daily struggle for survival and a beneficiary's love of European films. Every Sunday afternoon the film club offers moments of relaxation to its fervent supporters. The Latsis Foundation has provided a pop-corn machine and Mondelese a new screen and speakers.
- Hairdresser's: Following the kind sponsorship
 of Loreal, the space that has been arranged has
 provided the volunteer that runs the hairdresser's
 with the chance to give a new look to hundreds of
 people who trusted her experienced hands and
 scissors!

A total of 45 volunteers regularly offer their time for the Day Centre 's operation at the wardrobe, reception, technical support and more. They provide the Day Centres with the color and the special moment that can change the routine of people using their services. We thank them all from our heart!!!

Employment Assistance

Since August 2014 the Day Centre's team has been strengthened by an employment counselor who underwent 288 sessions for 50 individuals; in the context of synergies with other PRAKSIS programs, a seminar for interview skills was held in December. A total of six individuals were absorbed in the labor market.





DAY CENTER FOR THE HOMELESS IN THESSALONIKI

In 2014 began the service of the Open Day Center for the Homeless, which was the first to operate in the city of Thessaloniki. Its operation combined synergies from the Local Government, the Private sector and the Civil Society. More specifically, it was integrated from the very start in the funding within the framework for the OP Human Resources Development 2007-2013 implementation, with cofinancing of the European Social Fund in the framework of the project: Social Structures Confronting Poverty in Thessaloniki Municipality in ARSIS partnership, as beneficiary, Thessaloniki Municipality and PRAKSIS as associates. The Bodossaki Foundation supported the operation with the cost of the building rental, while the Stavros Niarchos Foundation contributed to the necessary changes in the site as well as to the support with human workforce. During the operation, companies embraced the act by funding snacks, supplies or clothing.

From May to September 2014, 625 people have been recorded of which more than 50% lives on the streets, and 85% are men. The average age is 35 years old, while the educational level covers all educational levels.

The tables below reflect the profile features of the people who use the Day Center in Thessaloniki. The main demand in this Day Center is also finding housing.





COLLABORATIONS EUROPEAN COOPERATION PROGRAMMES



The main activities of the Programme are seminars or/and focus groups mainly at regional and local level with a view to, among other things:

- increasing and extending the participation of adults in life-long learning;
- improving their literacy and numeracy skills, and developing their skills in the area of digital technology;
- increasing the provision of adult learning and encouraging adults to acquire knowledge as a means of strengthening their social integration and active participation in the community as well as the society, and
- raising awareness of and stimulating people to complete higher levels of education, especially those who leave school prematurely.

PRAKSIS has implemented good practices related to life-long learning:

- There are internet corners¹ in all PRAKSIS establishments (Polyclinics, Social Housing, Homeless Day Centres) which offer a second chance to individuals and groups of people with low qualifications with regards to the improvement of basic skills such as reading and writing as well as the use of digital technologies. In these corners, in addition to Internet access, beneficiaries are provided with education on new technologies so as to be able to draft their own CV, look for work online, and participate in interactive or/and educational programmes by themselves.
- Specifically, with regards to migrant-targeted education, PRAKSIS, in the framework of the Offices for the Promotion of Employment, boosts the blending of existing skills that migrants may have already acquired in their country of origin while

at the same time, gives them the possibility to adjust them to the new environment. For instance, a migrant from the Former Soviet Union, who studied medicine in his country and cannot have his diploma recognised in Greece, is motivated to improve his Greek so as to work as a nurse (through special accelerated education in a vocational training centre (KEK) or/and institute of professional training (IEK).

- As far as Not In Education, Employment or Training (NEETs) people are concerned, namely those who have never been educated or professionally trained and who have no skills (in particular unaccompanied minors and Greek children who prematurely leave school in regions of Greece in which the drop-out rate is high), PRAKSIS implements the following models:
 - Remedial teaching and buddy system (a model of volunteer-beneficiary liaison so as to boost the participation of the latter in educational, intercultural and social issues): strengthening and motivation for creative learning and education with a view to integrating the Greek society. To that end, PRAKSIS participates in the European programme PARES in cooperation with OAED and Man Power company through which we support the access of these population groups to apprenticeship schools.
 - Mobile School The programme has been taking place in Thessaloniki since October 2009 with the cooperation of PRAKSIS and ARSIS NGOs following the petition of both organisations to the "MOBILE SCHOOL" organisation in Belgium. The target group that this program addresses is a group of children aged from 5 to 18, who spend most hours of their day "work-

• Targeted education also touches upon entrepreneurial issues through which we try to promote the skills of people who get in touch with us. PRAKSIS Business Coaching Centre (PRAKSIS BCC) deals with this part of our work.

• With regards to the very important topic of cooperation with employers, social partners and civil society, the tools and practices of PRAKSIS are linked to the "Syn sto Plin²" programme and mainly to the preventive axis (Social Housing) with job promotion as its second basic pillar. To achieve this, we have established a dynamic system for job search which we use it in order to promote the beneficiaries of the programme to the open labour market. Mapping takes place so that the whole system is dynamic. The mapping refers not only to the business fields but also to the populations that could be absorbed per business field.

The above-mentioned programmes implemented by PRAKSIS are also Good Practices which target funding through different funding tools (national and European ones as well as those of the Private sector and Corporate Social Responsibility). For example, the Offices for the Promotion of Employment for asylum-seekers hae been occasionally funded by the European Refugee Fund, the PARES programme (European fund), the Equal programmes (first and second cycle) in which PRAKSIS participated and aimed at professionally reinstating unemployed with low qualifications and skills, immigrants, refugees, single-parent families, etc.

PRAKSIS, with regards to the implementation of its actions and interventions, focuses on cost efficiency, cost effectiveness, the social impact, the employability of the target-populations as well as the relation with these actions and preventions.

The company CMT Prooptiki Ltd. in collaboration with PRAKSIS NGO [in accordance with Decision of 25/08/2014 of the General Secretariat for Gender Equality, (AΔA/Online Publication Number: $6\Psi K\Sigma N-M\Gamma 6$)], will be conducting a research entitled: "Prostitution & trafficking and smuggling of women for the purpose of sexual/commercial exploitation in Greece".

The project is placed in the E.P "Administrative Reform 2007-2013" and is co-funded by Greece and the European Union.

The goals of the project are specialized as follows:

- Locating/ demonstrating the circumstances and factors that incline in the rise of the phenomenon of prostitution and of illegal smuggling and selling of women in order to exploit them sexually/economically (trafficking)
- · Investigation and emblazonment of the way criminal organizations (modusoperandi) are exploiting/ attracting women- the victims of trafficking (i.e advertisements in newspapers, online presence, entertainment centers etc.) and of the ways such services are created/multiplied.
- Emblazonment and evaluation of the consequences of prostitution and trafficking of women in Greece in a personal, social, political and cultural level.
- Investigation and emblazonment of the way prostitution and trafficking is addressed by the organizations involved and by the Greek society in general.

- Collecting and analyzing data in order to evaluate the quantitative and quality indicators concerning the violence against women, based on the Action Program of Beijing and on the specializations made by the European Union.
- Emblazonment and evaluation of the adequacy and sufficiency of political actions and mechanisms concerning the confrontation of prostitution and illegal trafficking of women and the support provided.
- Designation of priorities in every section of the public policy in order to improve the system dealing with the illegal trafficking of women and with their protection.
- Formation of proposals concerning the development of specific strategies in order to appease the phenomenon of illegal trafficking of women for the purpose of economical/ sexual exploitation.







The PRUMA project aimed at promoting the efficient and safe family reunification of unaccompanied minor asylum seekers (hereinafter UMASs), tried to address procedural gaps by developing Standard Operating Procedures (SOPs) for the family reunification of Unaccompanied Minor Asylum Seekers under the Dublin Regulation.

While over the last years, more attention has been devoted to the protection of unaccompanied or separated child in most EU MSs, there is still a gap in the capacity of assessing the best interest of a child when it comes to his/her transfer for family reunification purposes, under the Dublin Regulation. That is, when found a to be in the best interest of the Child, ensuring timely identification, enhancing coordination among relevant Dublin Units and speeding up transfer procedures is paramount for the protection of an unaccompanied child.

IOM Rome was the Coordinator of the project and the project was implemented in 7 EU MSs: Italy, Malta, Greece, France, UK, Norway and Germany. The partners were: IOM France, IOM Germany, IOM Greece, IOM Malta, IOM UK, SAVE THE CHILDREN ITALIA ONLUS, CIVICO ZERO ONLUS, PRAKSIS, UK Refugee Council, Bundesfachverband Unbegleitete Minderjährige. UNHCR Brussels, Ministry of Citizen Protection Greece and Malta Police supported and cooperated the project.

The main project activities are:

- Development of a common proposal of standard operating procedures for family reunification under the Dublin Regulation
- Development of National Standard Operating Procedures in participating countries
- Testing of the Standard Operating Procedures and Support to Family Reunification of UMASs through outreach activities to carried out in two pre-identified centres in Greece and Italy and relevant casework in other participating countries
- Presentation and dissemination of the SOPs developed and tested throughout project implementation.

Alliance against Poverty

Alliance against Poverty constitutes a dynamic forum of thirty-three – until now – Greek organizations that was created as a response to GCAP (Global Call To Action Against Poverty), the largest campaign that has ever been made by organizations and civil society from all over the world for the termination of poverty and for a fairer and more humane world. Alliance, by uniting its powers with the global movement for the fight against universal poverty and inequality, focuses its action on four axes: 1. adoption of fair international transactions; 2. increase of the quantity and upgrading the quality of the humanitarian assistance; 3. immediate cancellation of debt of poor countries 4. emergency actions for confronting climate change.

Network of Carriers

Participants include: KETHEA Mosaic, PRAKSIS, ARSIS, Network for the Rights of the Child, One Child One World, the NGO "Medical intervention"- MEDIN, the Center of Child Support, KΨY of the Sotiria Hospital, and the Center for Addiction Prevention and Health Education "Athina Health". The network seeks to cover the needs that arise due to the crisis, through the distribution of information for the actions of participating entities and the wider audience. At present, it has organized one meeting that was addressed to school directors and had as an aim to present the organizations that compose the Network.

Group for Citizenship

The Group for Citizenship monitors the developments in the controversial issue of citizenship-naturalization in Greece which became more complex after the decision of the Council of the State regarding the anti-constitutionality of the law 3838/10. Various organizations, for example, the Hellenic Union for the Rights of Man, the Network for Political and Social Rights, and others, as well as political entities, try to highlight the issue and its consequences in the everyday life of immigrants and their children.



60 volunteer organisations and hundreds of volunteers celebrated their altruism and contribution. Volunteerism and solidarity are increasingly evident necessary elements for a lively, healthy and developing society.

ATHENS PRIDE

PRAKSIS participated with a booth and information and education material as part of the celebration. The mobile unit was there, offering rapid, free and anonymous HIV testing.

HIV TESTING WEEK/ "Talk about HIV- Get tested"

The first European Testing week for HIV was organised alongside the Center of Life and Checkpoint. During the week (from 10am until midnight) 1000 tests were conducted in all PRAKSIS facilities and its four mobile units

Three days of events around HIV/AIDS awareness- Omonoia Square

In collaboration with the Center of Life and Positive Voice, three days of events to raise awareness around HIV/AIDS were organised with other actors. A press briefing was organised at the Athens Cultural Centre followed by the creation of a human red ribbon which marked the end of the three days.

International Refugee day

Christopher the Magician put together an elaborate event during which, with his magic tricks he managed to intrigue and amuse the young asylum seekers who are living at the STEGI PLUS (+) home in Athens.

International day against drug abuse/ Koumoundourou Square

In partnership with the Organisation Against Drugs. PRAKSIS was present in Koumoundourou Square with a mobile unit and a booth in order to provide information and material.

Concert for the street magazine Shedia/

The PRAKSIS mobile unit was invited to SHEDIA's concert in order to perform free, anonymous and rapid tests for HIV during the whole event.

MONEY SHOW/HILTON

PRAKSIS took part with an information booth highlighting its activities, as well as with the presence of volunteers active in the centre for unaccompanied minors STEGI PLUS (+) as part of the volunteer programme Buddy Sytstem.

Participation in the Athens College Bazaar

The bazaar was organised by the Athens College Alumni Association with the aim of raising funds to support PRAKSIS' work.



Anti-racist Festival

PRAKSIS took part in the 18th anti-racist festival which took part on 4.5.6 September at the Athens University Campus with the presence of a booth and the distribution of information material.

Valentine's Day

With a large crowd of invitees made up of partners, volunteers and employees the Valentine 's Day party took place at Romantso. Parallel and interactive events took place during the party including the search for a partner sign that invitees were given upon their arrival, an especially designed photo booths (kind donation from YARD productions), piñatas with gifts and many more.

10 years of PRAKSIS celebration party

Volunteers, employees and partners all came together at Disco Boom Boom to celebrate, and did so until the early hours of the morning.

Awareness Raising day by the Haidari Scouts- Haidari Municipality

PRAKSIS took part in this event hosted by the Haidari Scouts on October 18 with the presence of a mobile unit to test for HIV and Hepatitis B&C. The event was intended to raise awareness among the local community around participation in voluntary activities.



Young Lions

PRAKSIS was selected by the Advertising and Communication Agencies Union of Greece to take part in the Young Lions process during which young innovators and up to 28 years old are called upon to present a proposal around communication for a social issue within 24 hours from the time of their first briefing. In 2014, PRAKSIS participated alongside the Union during the brief, providing information on human trafficking. In 24 hours, the participants presented their proposals. 33 of these received support in various categories including print, video, social media etc. The presentations and awards ceremony took place at the event centre ROMANTSO.

Event on human rights and the combatting of corruption- corporate social responsibility network

The aims of the event which took place on December 5th at the American Farm School in Thessaloniki, were to raise awareness, exchange opinions, and call to action around the respect for human rights and the combatting of corruption. Awareness-raising campaign against Hepatitis B.

Within the framework of ASK FIRST campaign and continuing to provide information on Hepatitis B. PRAKSIS initiated a six-month information campaign against Hepatitis B all over Greece under the scientific support of the Hellenic Association for the Study of the Liver and the collaboration of the Hellenic Liver Patient Association "Prometheus". With printed material translated in seven (7) languages, television and radio spots, the aim was and still is to raise the awareness of the people living in Greece (Greek and Foreigners) regarding the ways of transmission and prevention of Hepatitis B. During November PRAKSIS had been giving people the opportunity to get a free test for Hepatitis B. The test was performed with blood sample taking on a daily basis in Thessaloniki Polyclinic, while the mobile unit of the organization was out in the streets at different spots in Achaea and Ioannina informing the general population regarding Hepatitis B as well as the opportunity to get a Free Test.

In the framework of the same campaign Press Conferences were held in order to announce the results of the pilot month testing. In the Press Conferences, demographic data of the pilot program's sample were presented in addition to the results, without making reference to any personal data of the population tested. Apart from that, the aim of the Press Conference was to open a door to the participation of other pharmaceutical companies so as for as many associates as possible in this field to support this campaign. In this manner, a strong and firm collaboration could develop which would be comprised of people with great experience and knowledge in this field and maybe in the future will turn into a «net of protection» for those who do not have any access to health due to social, economic exclusion or other reasons.

Syn sto Plin, Campaign for addressing homelessness – There's a fine line between...

In the framework of Syn sto Plin program, the campaign carried on with a television and radio spot, posters, web posts & banners which aimed at raising the awareness and providing information on the issue of Homelessness. The campaign addressed the public in order to show that there is a very fine line between the financial security and homelessness which was the campaign's slogan: «There's a fine line between».

European HIV testing week:

With the motto "TALK ABOUT HIV – DO THE TEST" PRAKSIS realized for the second year, during a week, an information and awareness raising action as well as HIV testing on the spot in Athens, Thessaloniki and Patras. The program was co-organized by PRAKSIS, Kentro Zois and Thetiki Foni (Positive Voice) while supporters to this attempt were KETHEA, KETHEA Prometheus, OKANA et al.

In Athens the streetwork was performed on a daily basis in STEGI SYNATHINA as well as in a different Municipality per day. Additionally, the action was accompanied by the participation of music productions and the atrical performances by NGO TECHNODROMO and its theatrical team. The HIV Testing Week was supported with the presence of the Mayor of Athens Mr. Yiorgios Kaminis, the Ambassador of Holland in Greece Mr. Jan Versteeg and others who were also tested.

In Thessaloniki the Mobile Unit visited seven different spots of the city. THESSALONIKI GAY PRIDE also provided their support. Additionally, the implementation of the Testing Week was supported by the Municipality of Thessaloniki, the Municipality of Ambelokipi, the Municipality of Evosmos, the Municipality of Kalamaria, the Aristotle University, DIPETHE, FC Iraklis, www.provocateurmagazine.com and Block 33. This action was supported among others by the Mayor Thessaloniki Mr. Yiannis Boutaris and the Deputy Mayor of Thessaloniki Ms. Goula Calypso.

At the same time, in Patras a series of actions took place at Agiou Georgiou square informing people about HIV/AIDS and HIV tests were conducted daily. Among others, Maria Andrikopoulou, Deputy Mayor of Patras, honored us with her presence and took the rapid HIV test.

Three Day Exhibition «POSITIVE LIFE ACTIONS» for HIV/AIDS- Omonoia Square

During the three-day period from 29-30/11 to 01/12, events and information campaigns about HIV were held, culminating in the World AIDS Day. PRAKSIS participated in a campaign aiming at information and awareness raising which received a strong and positive response in Athens, Thessaloniki and Patras.

In Athens a joint press conference was held in the City of Athens Cultural Center by PRAKSIS, Kentro Zois and Thetiki Foni where results from the HIV Testing Week and proposals for further action were presented to Political Leaders and Civil Society. After the press conference, events were held in Omonoia square starting at Stoa Janero where a huge human red ribbon, international symbol of World AIDS Day, was formed.




